### Jerald Feinstein Planet StartUp

Planet Startup mentors and coaches unemployed young adults residing in developing, remote, or marginalized areas of the world to set up and run their own internet-based companies. Connecting them with investors, partners, and mentors helps them to succeed.

Unique in what they do and how they do it, mentors and business leaders from all over the world use virtual meeting internet platforms to lecture to, and work with, unemployed young adults in high poverty areas to help

them build businesses, and then link them up with investors, venture capitalists, and partners.

Using a model created by Planet Startup before Shark Tank existed, a growing list of investors and venture capitalists listen to participant presentations and depending on their interest in the student projects, might offer an investment or partnership opportunity to grow the fledgling business.

In the US, Planet Startup collaborates with Saylor Academy to provide free, virtual AI accredited classes that lead to undergraduate college credits. And partnering with the Greater Fort Lauderdale Chamber of Commerce, offer after-school high school programs that allow students to present their ideas to Chamber members which may allow the continuation of their project by working with that member, or sometimes the students are offered jobs.

Florida Nonprofits spoke with Jerald about his organization.

#### How did you get started with Planet Startup?

I was a visiting Fellow at Harvard University where the global entrepreneurial idea was first envisioned. The original curriculum and set of classes for the program were developed at Harvard and George Washington University. When I was invited to talk to 800 women in Ghana, the overwhelming response was the desire to start a program there as well.

#### What do you like best and least about the work you do?

The feeling of accomplishing something, making a difference, and igniting the spark in others to learn and grow brings me great satisfaction. Doing paperwork and dealing with the legal and financial aspects are just part of what has to get done, so I do it.
